

CFMOTO CFMOTO Accessory and Generator Limited Warranty

Thank you for purchasing a CFMOTO accessory product or CFMOTO generator. If your purchase is found to be defective in materials or workmanship within the terms and conditions of this Limited Warranty, it will be repaired or replaced (at the option of CFMOTO) at any authorized dealer located within the United States. This CFMOTO Accessory and Generator Limited Warranty is subject to the following Terms and Conditions:

WARRANTY PERIOD AND COVERAGE - Accessory Products: The CFMOTO accessory warranty period is ninety (90) days from the date of purchase from an authorized CFMOTO POWERSPORTS, Inc., Dealer. Warranty coverage applies only to the use of CFMOTO accessories within the continental United States and to accessory products sold by authorized CFMOTO POWERSPORTS Inc. Dealers. During the warranty period, CFMOTO POWERSPORTS Inc. will cover repair or replacement of CFMOTO accessory products due to a defect in material and/or workmanship. Warranty coverage of an accessory shall not exceed the cost of replacement, to include diagnostic and/or repair charges. In the event of product repair or replacement, the warranty period is not extended, and continues to run from the original purchase date.

WARRANTY PERIOD AND COVERAGE - Generators: The CFMOTO generator warranty period is 12 months (1 year) from the date of purchase from an authorized CFMOTO POWERSPORTS, Inc., Dealer. Warranty coverage applies only to the use of CFMOTO generators within the continental United States and to generator products sold by authorized CFMOTO POWERSPORTS Inc. Dealers. During the warranty period, CFMOTO POWERSPORTS Inc. will cover repair or replacement of CFMOTO generator products due to a defect in material and/or workmanship. Warranty coverage of an accessory shall not exceed the cost of replacement, to include diagnostic and/or repair charges. In the event of product repair or replacement, the warranty period is not extended and continues to run from the original purchase date.

EXCLUSIONS FROM WARRANTY COVERAGE: Any damage resulting from the following acts or circumstances is not covered by the CFMOTO POWERSPORTS, Inc., Accessory and Generator Limited Warranty: Fire / Collision / Theft / Submersion / Improper storage or transportation / Failure or negligence in the performance of periodic maintenance, use, or operation / Unauthorized repairs or adjustments / Unauthorized modifications / Use in a rental setting / Use in competitive or racing events / Unavoidable natural disasters. Labor costs to remove and install accessory or generator products are specifically excluded.

HOW TO SUBMIT FOR WARRANTY: At the appearance of an anomaly, the customer should stop using the product, contact an authorized CFMOTO POWERSPORTS, Inc. Dealer, and present the product along with proof of purchase for inspection. Any warranty repair or replacement must be submitted exclusively through a CFMOTO POWERSPORTS, Inc. authorized Dealer. Product repair or replacement by anyone other than an authorized CFMOTO Dealer will not be covered under this CFMOTO POWERSPORTS, Inc. Accessory and Generator Limited Warranty.

DEALER WARRANTY PROCESS: Upon submission of a CFMOTO product and proof of purchase to an authorized CFMOTO Dealer, the Dealer will submit a claim for warranty consideration through the Return Merchandise Authorization (RMA) section of their Dealer Portal. Decisions regarding warranty coverage will be determined through communication between the authorized dealer and CFMOTO POWERSPORTS, Inc.
